Terms and conditions of use through this notice

Data collection

In compliance with Organic Law 15/1999, of December 13, on the Protection of Personal Data, we inform you that the personal data requested in our forms will be included in a personal data file, whose owner and manager is Javier Gonzalez Robles. Likewise, when a person fills in any of the forms with the personal data requested and accepts the shipment, they expressly authorize Javier González Robles to process or incorporate into the automated file owned by them the personal data provided in the aforementioned form and all data generated in relation to your participation or use of the different events offered on this website.

Unless specifically stated otherwise, it will be considered necessary to fill in all the fields of each form. To do this, the user must fill in the forms with true, exact, complete and updated data. The user will be solely responsible for any damage or harm, direct or indirect, caused to Javier González Robles or to any third party due to filling in the forms with false, inaccurate, incomplete, out-of-date data or data from third parties. Purposes of the treatment
